### CONTRACT

This contract is between All Creatures and the pet owner/guardian whose signature appears below.

1. Owner/Guardian agrees to pay the rate for boarding in effect on the date pet is checked into the kennel.
2. Owner/Guardian further agrees to pay all costs and charges for special services requested, and all veterinary costs.
3. Owner/Guardian agrees pet shall not leave the kennel until all charges are paid.
4. All Creatures shall exercise reasonable care for the pet delivered by the owner/guardian. It is expressly agreed by owner/guardian and All Creatures that All Creatures liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal boarded. The owner/guardian further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of All Creatures.
5. All charges incurred by owner/guardian shall be payable upon pick-up of pet.
6. The owner/guardian hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, All Creatures may exercise its lien rights upon ten days written notice given by All Creatures to owner/guardian by certified mail to address shown on contract. All Creatures may dispose of pet in the sole discretion of All Creatures, and owner/guardian specifically waives all statutory of legal rights to the contrary.
7. If pet becomes ill, All Creatures in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the owner/guardian.
8. This contract contains the entire agreement between the parties. All terms and conditions of the contract shall be binding on their heirs, administrators, personal representatives and assigns of the owner and All Creatures.
9. Any controversy or claim arising out of or relating to the contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
